*The Michigan Association of School Board Membership dues are paid annually. This is the first year they asked for it to be Board approved.*

- f. **Substitute Teacher Daily Wage Increase – Red Rover**  
*Bentley currently pays our substitute teachers \$80 per day. Across the county pay increase are being discussed for due to the lack of substitutes available. After much discussion, the BOE agreement to raise the daily rate to \$90 along with providing a lunch coupon. We will also be looking at other ways to enhance the substitute experience at Bentley.*  
  
*We currently have AESOP as our substitute teacher provider. The majority of districts in Genesee County are moving to RED ROVER. Because we will be part of a consortium, the five-year contract will be a cost savings to the District.*
- g. **Approve Overnight Band Camp**  
*Donavon Tear has requested permission for students to attend an overnight Band Camp at Camp Lael. Our students will be the only ones in attendance. The United Way has given \$600 towards the cost. Dr. Spann is also attempting to get additional funding from Walmart. Students will have to pay a portion of the cost.*
- h. **Superintendent Contract**  
*The Board clarified vacation days for Dr. Spann. Her three-year contract will allow for five days to be paid out in June and five days to be used by July 31<sup>st</sup>. It was agreed that her contract would also allow her to bank forty sick days.*
